SPORTS CAR – DESIGNED BY THE MANUFACTURER WITH AN EMPHASIS ON DYNAMIC PERFORMANCE.

TRUCK – VEHICLES DESIGNED TO HAUL GOODS AND MATERIALS.

4X4 – 4-WHEEL DRIVE VEHICLES DESIGNED FOR MORE RUGGED TERRAIN THAT HAS BEEN RESTORED.

WALLOWA COUNTY – OWNER HOUSED IN, AND VEHICLE GARAGED IN WALLOWA COUNTY.
