

***VENDOR GATE WILL OPEN FRIDAY- NOON TO 8 PM**
***VENDORS WILL BE ALLOWED TO ENTER ON SATURDAY MORNING AT 6 AM**
***SWAP MEET HOURS 8 AM TO 2 PM SATURDAY**

1. Unloading time on **Friday** starting at noon. Only individuals with a **VENDOR PASS** will be admitted. Two (2) vendor passes issued with each registration. The doors will be locked at 8 pm Friday.
Vendors must vacate the building by 3:30 pm Saturday evening.
2. A club host will be on duty Friday evening and all buildings and grounds will be locked at 8 pm sharp. We do suggest that vendor be on hand whenever the doors are open.
3. *In fairness to all vendors and customers, tear-down/move-out of booth operators will not be allowed to commence earlier than 2 pm Saturday.*
4. **ABSOLUTELY NO GUNS ARE ALLOWED TO BE TRADED, CARRIED. OR SOLD.**
5. No alcoholic beverages may be consumed at Clatsop County Fairgrounds.
6. Vendor is responsible for the cleaning of their space prior to departure. **Do not use tape, drive nails or tacks into the walls, tables, etc.**
7. While unloading and loading, vendor is asked to do so as quickly as possible, then move his/her vehicle to the parking lot across the road. Vendor will be allowed to “hand load” during any open hours. Vehicles left blocking aisles or fire lanes will be towed at owners’ expense.
8. This event is primarily an “**AUTO SWAP MEET**”. However, a number of spaces will be rented for “non-automotive” – related use – on a “first-come/first served” basis.
9. The pre-registration fee is for the swap meet or any part thereof. Space or tables not claimed by 8 am Saturday may be re-rented, with no refund. **NO REFUNDS** will be made for cancellations made later than 72 hours prior to the event.
10. **Overnight stays must be reserved in advance through the Clatsop Co. Fairgrounds – 503-325-4600**
11. We reserve the right to refuse to rent a space to anyone. We require that you have at least 75% or more car items, tools, literature, parts, etc., except for “non-automotive” spaces.
12. Vendor agrees to indemnify and hold harmless the Lower Columbia Classics Car Club and individual members from any and all costs and expenses by reason of any claim concerning the quality or title to any part or item sold or traded by vendor.
